Affordable Housing:

- The board discussed current issues in Cleveland Park and agreed to the following principles and questions:

Transportation

- The board approved Sauleh as a co-chair of the Transportation committee with Naihua
- The committee noted that ANC 3C01 Commissioner Lee Brian Reba is leading an
 investigation into extending the Circulator Green Line bus service to the zoo and
 possibly beyond. CPCA will review the findings from this investigation and decide how to
 proceed.
- The committee will continue to research 4-2 lanes.
- The committee will explore collaboration with Woodley Park and other neighborhood orgs on transportation issues.

Survey
